«Fees for the provision of aggregated published market data, upon ad hoc request»

**THE HELLENIC ENERGY EXCHANGE S.A.
HAS DECIDED AS FOLLOWS:**

Article 1. Object – Application Scope

1. The object of this Decision is to determine the fees for the provision of market data in aggregated and standardized format in accordance with the into-force legal and regulatory framework for electricity and natural gas market published data managed by the Hellenic Energy Exchange S.A. (HEEx).
2. The service for provision of market published data in aggregated and standardized format is offered only upon request by any interested party.
3. The terms of this Decision have the same meaning as those given the Day-Ahead and Intra-Day Trading Rulebook, the Financial Energy Market Rulebook (Derivatives Market) and the Natural Gas Trading Rulebook.

Article 2. Fees per Market and File Type
