## ECC Exam overview and registration process

#### Overview

The study material for ECC examination can be found <a href="https://examination\_focuses">here</a>. The examination\_focuses on the regulatory framework of EnExClear's clearing & settlement procedures and main functions of the Energy Market Clearing System (EMCS). The examination uses the multiple-choice test system and it will be held either in English or Greek<sup>1</sup>.

## **Objectives**

The exams are conducted according to the relevant EnExClear Decisions. Exam objectives can be found at Decision 2: "Professional competence of Clearing Members".

#### **Pricing**

The Certification Fee is €210 (not subject to VAT charges).

The fee needs to be deposited to EnExClear's Bank Account\* until Monday 24/11/2025. The deposit information field should include the text: "EnExClear ECC Exam -" followed by the applicant's name.

#### **Registration Process**

#### 1. Registration

To participate in the ECC Exam, we kindly request you to:

- a) complete the online registration form <a href="here">here</a>. You are kindly requested to fill in your personal information in English. <a href="Registration">Registration is available until Monday 24/11/2025 at 15:00 EET</a>. Please note that any registration applications received after this time will not be processed
- b) fill out and send to <a href="mailto:training@enexgroup.gr">training@enexgroup.gr</a> the form CL2-1 "Application for the Energy Clearer Certificate" which can be found <a href="mailto:here">here</a>. The form should be digitally signed (with valid digital signature or digitally certified from gov.gr). Otherwise, you could certify your signature at a Citizen's Service Centers (ΚΕΠ) or with apostille (where applicable) and send the hardcopy to EnExClear premises.

- c) pay the certification fee and sent the deposit receipt to <u>training@enexgroup.gr</u>. Moreover, it is required to send us a copy of your Personal Identity or Passport, along with the required information listed below:
  - Company's name
  - Tax Registration Number
  - Company address
  - Name of the employee attending the examination
  - Number of Identity Card/Passport of the examinee

## 2. Training Material

Before the examination, you will receive useful training material via the email address provided during registration. This material will assist you in preparing for the examination and increasing your chances of success.

#### 3. Connection Details

Upon successful registration and payment, you will receive a confirmation email with a link to ProctorExam platform including all the required information and guidance for your System Check. The System Check should be concluded <u>within 48 hours before the ECC Exam</u>. Subsequently, you will receive an email with the link to join your Examination.
