# ETC<sub>g</sub> Exam overview and registration process

#### Overview

The study material for  $ETC_g$  examination can be found <u>here</u>. The examination\_focuses on the regulatory framework of HEnEx's Natural Gas Trading Platform, trading practice and main functions of the XnetTrader application. The examination uses the multiple-choice test system and it will be held either in English or Greek<sup>1</sup>.

Two Sessions will be held on the 17<sup>th</sup> of February 2022. <u>Employees of existing Participants of HEnEx</u>, will have priority concerning their participation in the exam's sessions.

After registering, you will be informed for your allocation in due time. In case of excessive number of examinees, HEnEx reserves the right to allocate them at a different exam day, which will be notified to interested parties in due time.

#### Objectives

The exams are conducted according to the relevant HEnEx Decisions. Exam objectives can be found at Decision 3: "<u>Participants' professional competence in the Natural Gas Trading Platform of HEnEx</u>".

#### Pricing

The Certification Fee is €150 (not subject to VAT charges).
