# EDTC Exam overview and registration process

## Overview

The study material for EDTC examination can be found [here](#). The examination focuses on the regulatory framework of HEnEx's Derivatives Market, the Trading System and related trading issues, as well as basic principles on clearing and settlement. The examination uses the multiple-choice test system and it will be held either in English or Greek<sup>1</sup>.

## Objectives

The exams are conducted according to the relevant HEnEx Decisions. Exam objectives can be found at Decision 3: "Members' professional competence in the Financial Energy Market (Derivatives Market) of HEnEx".

## Pricing

The Certification Fee is €150 (not subject to VAT charges).
